**EVENT DATES:** February 12<sup>th</sup>, 13<sup>th</sup> & 14<sup>th</sup>, 2010 (Friday, Saturday & Sunday).

**LOCATION:** Downtown Delray Beach (Beginning at North Swinton Avenue & grounds of Old School Square on the North side of Atlantic Avenue)

**EVENT:** The Delray Beach Garlic Fest is an upscale gourmet food & entertainment event, modeled after the original Gilroy Garlic Festival in California. Delray Beach Arts, inc. is a non-profit organization with the purpose and primary goal of supporting community projects, charitable groups and service organizations. The three-day Delray Beach Garlic Fest is designed as a fundraising opportunity for the non-profit groups that staff the event. More than \$250,000 has been contributed back to the community over the past ten years.

**ADMISSION:** Gated event (\$12 daily)

**ACTIVITIES:** The Garlic Fest offers a wide array of activities for the entire family including national act entertainment at the Main Stage, cooking competitions and demonstrations at Garlic Chef Stadium, garlic inspired foods at Gourmet Alley, recreational and educational activities in the Children's Area and a wide variety of arts and crafts and merchandise from our vendors.

# VENDOR RULES AND REGULATIONS

**SIGN AND DATE THIS FORM AND SUBMIT IT WITH YOUR APPLICATION.**

1. **MUST BE AN APPROVED 10 X 10 TENT IN GOOD CONDITION.** MUST USE WEIGHTS, NO STAKES ALLOWED.
2. YOU MUST ADHERE TO THE HOURS OF THE EVENT AS LISTED ON PAGE ONE. PARTICIPATION IS REQUIRED ON ALL THREE DAYS. **AN EARLY BREAKDOWN FEE OF \$100 WILL BE CHARGED.**
3. YOU **MUST BE SET-UP FOR INSPECTIONS 3 HOURS PRIOR** TO THE ANNOUNCED OPENING TIME ON FRIDAY, Feb. 12<sup>th</sup>. YOU MUST BE OPEN FOR BUSINESS 1 HOUR PRIOR TO THE PUBLISHED OPENING TIME ON FRIDAY, February 12<sup>th</sup>, SATURDAY, February 13<sup>th</sup> AND SUNDAY, February 14<sup>th</sup>.
4. YOU, YOUR STAFF, AND YOUR BOOTH MUST BE REMAIN NEAT, CLEAN AND KEPT IN AN ORDERLY FASHION. EXHIBITS AND DISPLAYS MUST BE CONTAINED WITHIN BOOTH SPACE. CONDUCT AND DISPLAYS MUST BE APPROPRIATE.
5. YOU AND YOUR STAFF MUST PHYSICALLY STAY WITHIN YOUR BOOTH AREA. IF YOU ARE COLLECTING INFORMATION FOR CONTESTS OR LEADS, YOU MAY NOT BLOCK OR IMPEDED TRAFFIC FLOW TO OTHER VENDORS.
6. VENDORS ARE RESPONSIBLE FOR THE COLLECTION AND PAYMENT OF THEIR OWN SALES TAX.
7. ONCE YOUR SPACE APPLICATION IS APPROVED **NO REFUNDS** WILL BE ISSUED.
8. THE EVENT STAFF IS WILL NOT BE LIABLE FOR ANY LOSSES OR DAMAGES OF ANY KIND THAT OCCURS AT YOUR BOOTH. THE EVENT STAFF HOWEVER, PROVIDES 24 HOUR SECURITY THROUGHOUT THE EVENT.
9. **A MAXIMUM OF 4 VENDOR WRIST BANDS** WILL BE GIVEN UPON VENDOR CHECK-IN, THIS AMOUNT IS NON-NEGOTIABLE.  
\* Bring your own dolly, there is no guarantee you will be able to drive up to your assigned booth.  
\* No selling/soliciting outside assigned booth area.
10. NO "KNOCK-OFF" ITEMS PERMITTED.
11. IF YOU ARE SAMPLING AN APPROVED FOOD PRODUCT AT YOUR BOOTH, YOU MUST PROVIDE A COPY OF YOUR LIABILITY INSURANCE CERTIFICATE WITH DELRAY BEACH ARTS, INC. LISTED AS AN ADDITIONAL INSURED AND FAXED TO 561-278-0555.
12. THERE ARE NO **REFUNDS ON DEPOSITS OR FOR CANCELLATION** OF EVENT DUE TO RAIN OR ACTS OF GOD.
13. NO PETS ALLOWED AT EVENT.
